- 4. My display must occupy my assigned booth space(s) only and not encroach into the aisles or other booths. Leafleting anywhere outside of my designated booth space(s) is not permitted. In addition, loud noises, including but not limited to, amplified music and PA systems may not be played at my booth.
- 5. I must occupy the booth(s) assigned to me. No booth changes will be made on site.
- 6. I grant the rights to use photographs of the event to the Carlsbad Marathon for its own purposes.
- 7. I must staff my booth(s) continuously during the listed event hours.
- 8. Vendors handling or selling any type of food product (including pre-packaged foods and energy bars) are required to have a City of San Diego health permit or temporary food facility permit or apply for one no later than 14 days prior to the expo opening date.
